On behalf of our board of directors, I am pleased to present the Casper College Foundation's annual report for the 2022-2023 fiscal year. As we reflect on the past year, it is with immense pride and gratitude that we acknowledge the collective efforts of our donors, partners, faculty, and staff in helping us support the college's mission to provide an education for a lifetime that will prepare individuals to thrive and adapt in an ever-changing world. We sincerely couldn't do it without you.

At the Foundation, we are also continuously adapting to an ever-changing world. Because of rising publication costs, our alumni association board voted last April to reduce the number of Footprint issues from two to one a year, saving approximately \$50,000 annually. This once-a-year issue will be printed in August, highlighting the prior school year. Over the past few years, we have included our annual report in the winter edition of Footprints. However, our June 30 year-end does not give us enough time to include our annual report in the August Footprints. Therefore, our annual report will now be a stand-alone mailing.

Through the generosity of our donors and partners, we provided vital resources and support to our students, faculty, and programs, empowering them to thrive and make meaningful contributions to our community and beyond. I am happy to report that our Foundation awarded 898 students with 1,501 scholarships in the past year, totaling almost \$1.6 million. Additionally, we supported Casper College with \$3.4 million for program support and college initiatives, ensuring that Casper College remains at the forefront of excellence and innovation in higher education.

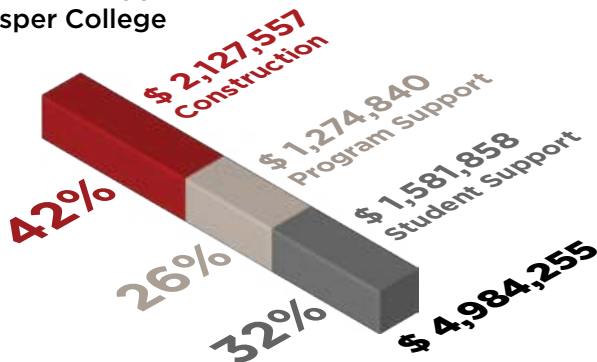
As we look ahead, we remain committed to our mission of excellence in education and community engagement. With your continued support, we will continue to create opportunities and transform lives.

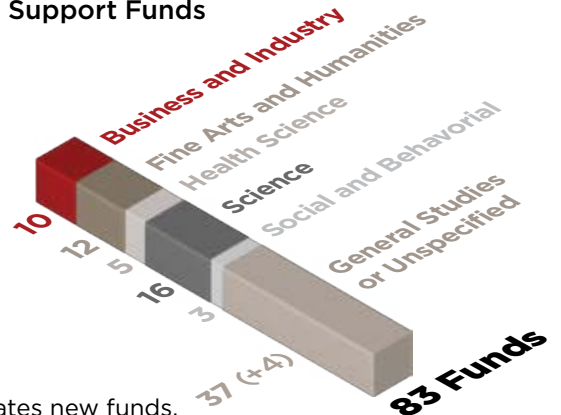

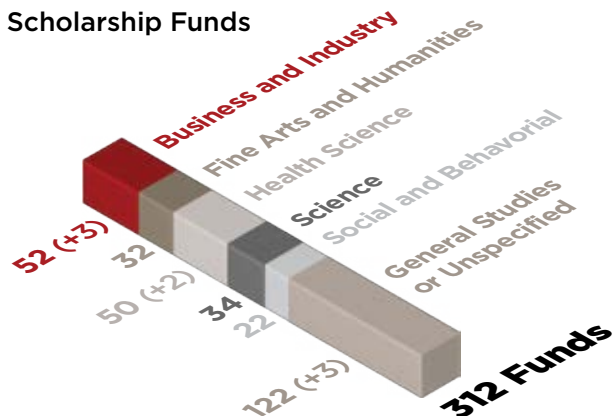
