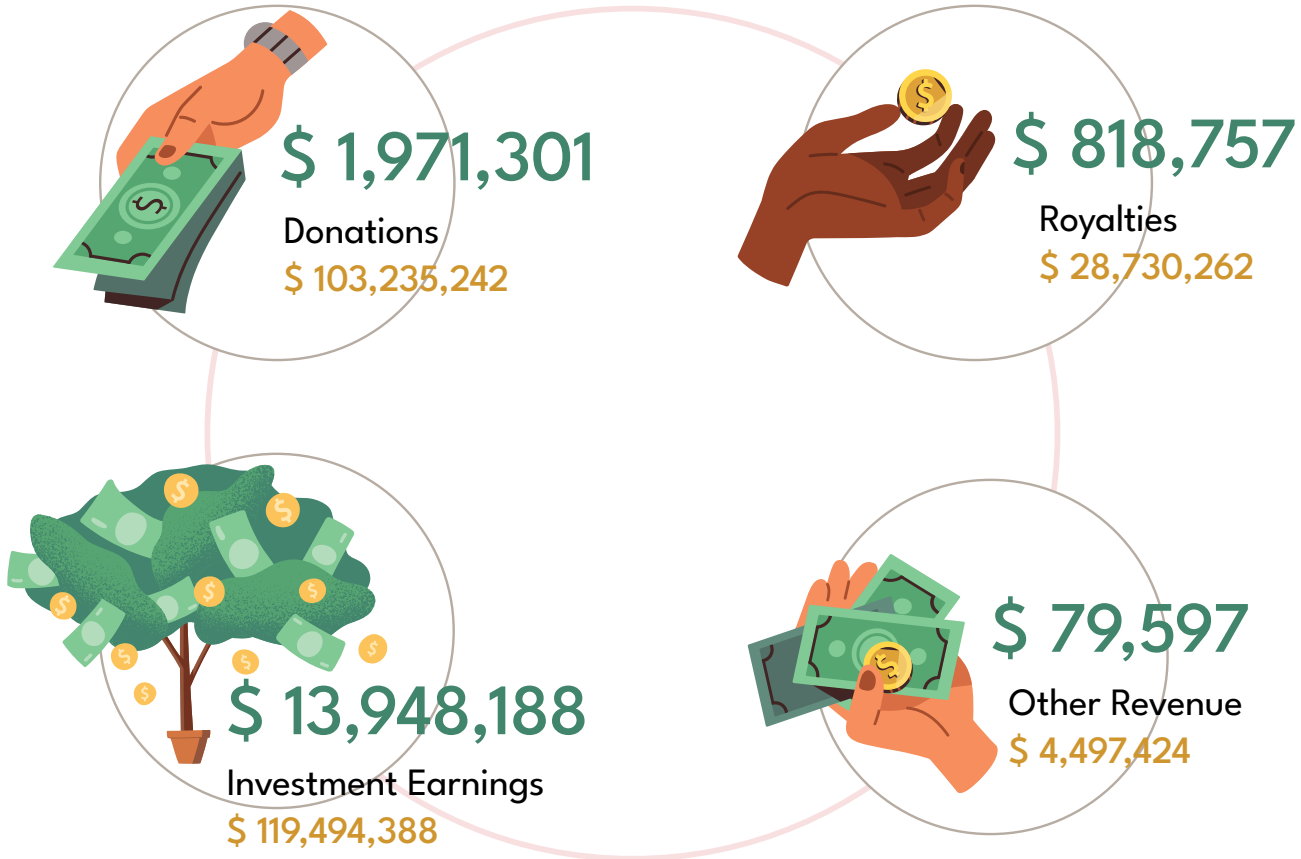

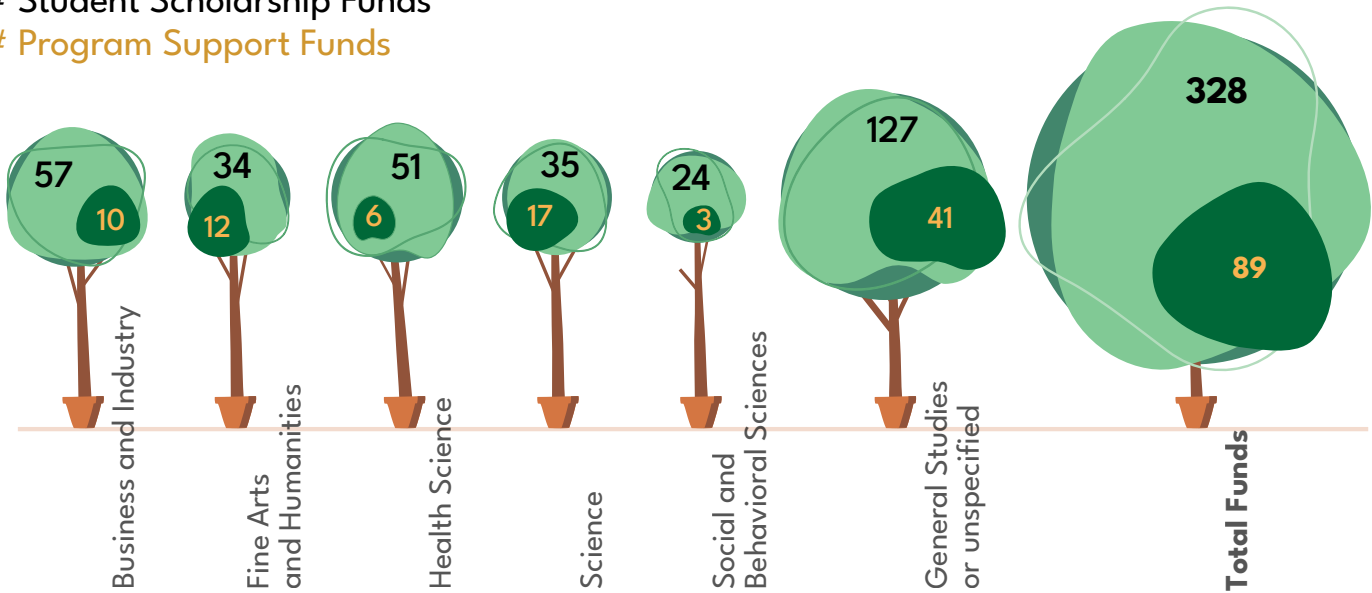

Program Support Funds



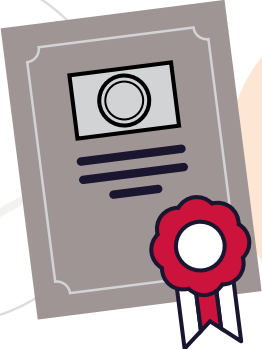

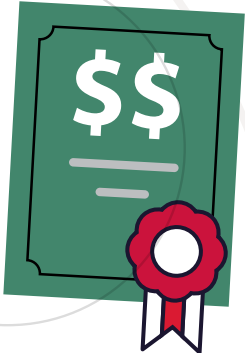

Mike Rowe and Casper College: A Perfect Match

The idea to bring Mike Rowe to Casper seemed like a dream for former Casper College President Darren Divine, Ph.D. and Denise Bressler ('84), Casper College Foundation executive director.

But, after some more thought and talking with those involved in three speaker series at the college: the Carl and Georgina Grosz Health Science Lecture Series, the Philip O. Doornbos Agriculture Lecture Series, and the Roy Chamberlain Business Enrichment Lecture Series, the dream took hold and became a reality. Mike Rowe and Casper College really were a perfect match.

Rowe came to Casper and delivered two presentations on Oct. 26, 2023. The first presentation, in the afternoon, was to Casper College and area high school students. The talk was geared toward young people still not employed in the workforce full time.

That evening, Rowe entertained a large crowd at the Ford Wyoming Center. "I like what he has to say, and his values align with a lot of Wyoming residents," said Bressler. "Mike's appearance also helped promote Casper College as a tremendous resource right in our own backyard," said Rachel Chadderdon, dean of the Casper College School of Business and Industry. "He elevates the trades to the status they deserve," she added.

Rowe is best known as the creator and host of Discovery Channel's "Dirty Jobs." After many years as host of "Dirty Jobs," which took him to every state in the nation, Rowe discovered that there was a disconnect in the country with the concept of "blue-collar workers." Rowe found that blue-collar workers "... didn't resemble the unflattering, blue-collar workers often portrayed in the media. ... Our society didn't, and still doesn't, have a trained workforce standing by or willing to fill the positions that actually exist."

Holiday High Tea Raises Money for CC Student Senate Food Pantry

The Casper College Foundation and Alumni Association held its first “Holiday High Tea” to support the Casper College Student Senate Food Pantry. Nearly 50 people attended the event, raising \$2,425 for the pantry.

Denise Bressler (*84), executive director of the Casper College Foundation and Alumni Association, came up with the idea of the High Tea fundraiser, with the funds going to the pantry. Checking with the rest of the foundation and alumni staff, she found that ... “the office wholeheartedly agreed.” With the Holiday High Tea held in December, close to the holidays, Bressler felt that the extra funds could help ... “students who need extra support during this time of year.”

Feedback from high tea participants was very positive. “We had donors, staff, retirees, OLLI members, and people who didn’t have a connection to the college. It was great to see such a diverse group of people together on campus,” noted Bressler.

Holiday High Tea attendees were treated to nine different kinds of Harney & Sons tea, steamed milk, lemon slices, sugar cubes, and honey from Sunshine Honey to put in the tea. According to Bressler, the honey was donated by James Colva, owner of Sunshine Honey. “We also had scones and biscuits with clotted cream, little cheesecakes, cucumber, tuna fish and egg salad sandwiches, and little brownies. Each person received a Hammond’s candy cane to take home, and one lucky person won a reindeer made of sticks with a pot of succulents,” Bressler said. Zachary

Vreeman, DMA, brought the Casper College Collegiate Chorale to the event to sing Christmas Carols at each table.

The pantry opened in the fall of 2020. “The food pantry started as an initiative led by the CC Student Senate. The Senate was eager to address food insecurity as an issue among students,” said Devin Fulton, student life coordinator.

The food pantry is open to any student attending Casper College and its partner institutions, the University of Wyoming at Casper and the University of North Dakota OT Program at Casper. Students from the Castellow Adult Learning Center at Casper College can also use the pantry.

According to Fulton, popular food items with the students who use the pantry are frozen dinners, Hot Pockets, ramen noodles, canned tuna or chicken, and pasta sauce and noodles. Popular hygiene items include toilet paper, paper towels, shampoo and conditioner, body wash, and razors. The pantry is open to students living both on and off campus.

As an indicator of how used the pantry is, from August to November 2023, the pantry saw over 500 visits, with 185 unique students. More women, 61%, than men, 39%, used the pantry.

Henrietta M. Neighbor

Our mother, Henrietta, moved to Casper in 1966 and immediately fell in love with Wyoming. She appreciated the people and the expansive, wide-open spaces. She immersed herself in various community activities and causes. As a Red Cross volunteer, she traveled across the state from north to south and east to west, visiting different communities. She participated annually in the United Way Blue Envelope drive as a fundraiser and volunteered for the local literacy program, teaching many newcomers how to read and write in English. Additionally, she helped garner support for Casper's Senior Center and, along with her friends, organized the "City Side Walkers" to help keep Casper's streets free from wind-blown litter.

Early on, she decided to make her basement living quarters available to students and young people who were not "from Casper." Some of the first "temporary residents" were two Brazilian kayakers who had paddled the length of the Amazon River. They shared stories about the Pousada inns in Brazil, and from that point until her passing in 2001, her basement was home to various students, with the La Pousada sign always displayed in the front yard. In Portuguese, the common language of Brazil, "pousada" means "a place to land" or "a place to halt and rest."

We lost track of how many students lived with Henrietta over the years. However, the last two were affectionately known as "The Angels," as they provided significant assistance during her final months. Almost all of her residents were students from Casper College preparing for careers in the helping professions.

This September marked the 21st year of The Henrietta M. Neighbor Pousada Scholarship. Over the past two decades, Henrietta's children have traveled to Casper in September to meet the scholarship recipients. On each occasion, we shed tears as we recognized the profound impact the scholarship has had on students. As of this past September, 241 students have benefited from her scholarship, many of whom have described it as a lifeline for a better future. Our family has immensely enjoyed witnessing the scholarship's growth, thanks to the foundation's good stewardship and the addition of matching funds from the State of Wyoming.

Thank you to everyone who has made scholarships like the ones I have received possible. Your generosity isn't just a payment towards my tuition; it's the reason I have the ability and confidence to pursue my dreams. You've not only invested in my education, but in my future, and words alone cannot express how grateful I am for that.

I'm proud to say I am the first of my siblings to graduate high school, get a job, and pursue higher education. I grew up in a home where uncertainty was the norm — there were days I wasn't sure if there would be food on the table. But even in the worst moments, there was one thing I held onto: I was determined to break the cycle, and I was going to change the course of my life.

I didn't officially get an education until I was 17 when I enrolled in the HiSet, High School Equivalency Test, program at Casper College. But I had reached a point where I knew something had to change, and I was the only one who could make that happen. When I took the HiSet exam, I wasn't expecting much. But when I saw that I scored 86 out of

100, it felt like the biggest victory of my life. That following semester, I officially began pursuing a degree at Casper College.

Casper College is more than just a place for academics. It's been a community for me, a place where I have been able to push myself further than I ever thought possible. This last spring, I completed my degree in forensic science as an active member of the honors program, finishing with a cumulative GPA of 3.8. Going from someone with no education to graduating with honors is an achievement I hold dear to my heart.

But none of this would have been possible without the generous support of people like you. Scholarships aren't just financial assistance — they're a source of encouragement, a sign that someone believes in you and is willing to invest in your future and passions.

I would like to take a moment to give a special thanks to the donors for the Henrietta Neighbors and Alfred Persson scholarships. These scholarships are more than just a check to me; they're a message of belief and support. It's like having someone beside you saying, "I believe in you, and I'm with you every step of the way."

Currently, I'm a full-time student working toward my second degree in health science, which I will complete in the 2025 spring semester. In addition to my studies, I work full-time in Enrollment Services at Casper College, saving up money to pursue the next step in my journey — the nursing program, which I'm hoping to start next year.

My ultimate goal is to become a forensic nurse. Forensic nursing is a way for me to merge my passion for healthcare with my desire to work within the criminal justice system. It allows me to make a difference in people's lives at a time when they need it most. I know in my heart that is what I'm meant to do.

I feel an overwhelming sense of gratitude — not just for the scholarships I've received but for the opportunity to chase my dreams. I'm living proof that no matter where you start, with determination, hard work, and the support of a community like Casper College and its supporters, anything is possible. Thank you again, from the bottom of my heart. I will carry this gratitude with me throughout my career and beyond.
